## Lecturers



**Mr. Celso J.N. Manata** is Deputy Attorney General and serves as Legal Auditor at the Ministry of Internal Affairs and the Ministry of National Defense in Portugal. He has served as a magistrate since 1981 and has held positions such as Lecturer at the Center for Judicial Studies (1988/1992), Deputy and Chief of Staff of the Secretary of State for Justice and of the Ministers of Justice (1990/1992), Lecturer at the Judicial Police School (1993/1995), Coordinator of the Ombudsman (1993/1994) and Director General of Reinsertion and Prison Services (1994/2001 - 2016/2018). He has also been an Expert of the Council of Europe (CoE) and the UN, former member of the "Committee for the Prevention of Torture and Degrading Treatment or Punishment" of the CoE (2005/2015), and Member of the International Criminal and Penitentiary Foundation since 2016.

**Prof. Shadd Maruna** is a professor of criminology at Queen's University Belfast in Northern Ireland. Previously, he was the Dean of the Rutgers School of Criminal Justice (USA), and he has been a lecturer at the University of Cambridge and the University of Manchester. His research focuses on desistance from crime and implications for prisoner reintegration. His book *Making Good: How Ex-Convicts Reform and Rebuild Their Lives* was named the Outstanding Contribution to Criminology in 2001. He received the inaugural Research Medal from the Howard League for Penal Reform for the impact his research has had on the criminal justice system.
